Dated: Kahilipara, 11<sup>th</sup> July, 2023**ADMISSION ADVISORY TO COLLEGES AND UNIVERSITIES OFFERING  
UG PROGRAMMES**

With reference to the earlier notification vide DHE/NEP-2020/2022/46 dated 04/07/2023, it is notified that the following points are to be complied with for admission into the undergraduate programmes in the State Universities offering FYUGP and Govt./ Govt. Model College/ PDUAM/ Provincialized colleges under Gauhati University, Dibrugarh University and Bodoland University,

1. All the colleges and universities as above will release their institutional merit list in due compliance with the timeline as per the aforementioned notification only. Accordingly, **the first merit list must be out on 11 July**, through notice boards/institutional web portal and URL to be mandatorily put in the Samarth portal.
2. Only the applicants who have registered and completed form submission through Assam State Higher Education Admission Portal (<https://assamadmission.samarth.ac.in/>) and who have selected at least one programme will be eligible for admission.
3. Admission will remain open all days for the specified duration, and no selected candidate whose name is published in the Merit list will be denied admission if they turn up on any of the specified dates of that merit list, subject to the authenticity and validity of documents required for admissions.
4. The Merit List is to be prepared strictly based on the seats allotted by the affiliating University.
5. Admission can be simultaneously conducted for different programmes for which necessary Programme user credentials have been shared with the colleges/universities.
6. **No waiting list will be published for admission. Only a Merit List with specific seat quota, as approved by the concerned affiliating University, is to be published.** Seats remaining vacant after the first round of admission will be made available for candidates from the second merit list to be released on 15th July, and a third merit list will be prepared for seats left out from the second round of admission, which will be released on 20th July.
7. Vacant seats, after the third round of admission, will be open to be filled up through 'Spot Admission' on 23, 24 and 25<sup>th</sup> July, 2023.
8. Any applicant who did not apply during the application period from 14<sup>th</sup> June to 3<sup>rd</sup> July, 2023 will get an option to apply afresh in one or 10 programmes, **but only programmes or Institutions with vacant seats will be reflected during the second application drive from 20<sup>th</sup> July, 2023 to 22<sup>nd</sup> July, 2023.**
9. All applications during the second Admission drive will be filled and processed through the Assam Higher Education Admission portal only. All Institutions **are asked to strictly refrain from provisioning applications and admissions through their Institutional portal.**



10. Admissions against all such fresh applications to be received from **20<sup>th</sup> July to 22<sup>nd</sup> July, 2023** will be granted **during spot admissions on 23<sup>rd</sup>, 24<sup>th</sup> and 25<sup>th</sup> July, 2023**.
11. Applicants who would be granted admissions in the first three merit lists will not be able to apply afresh in the second application drive from 20<sup>th</sup> July, 2023 to 22<sup>nd</sup> July, 2023.
12. However, only the candidates who have **already registered or will be registered through the Assam State Higher Education Admission Portal** will be considered for **'Spot Admission'**.
13. **Candidates who do not take admission within the specified days in a particular round, will not be considered for the subsequent merit list again.**
14. For grant of admission under the **Fee Waiver scheme**, mandatory uploading of a **Family Income Certificate** issued by a competent authority is necessary. Hence, the Income certificate may be uploaded by the applicant in the applicant portal on the day of admission.
15. Admitted candidate's list will be updated by the colleges/universities on SAMARTH platform immediately after admission is granted to a student
16. Colleges are not allowed to change the students' choices in **either 'Major' or 'Minor', during spot admission without prior written consent of the students.**
17. The **application ID will be a provisional roll number for admitted students.** However, a link to generate roll numbers at SAMARTH platform will be activated for the Colleges after the admission process is closed.
18. **There is no platform fee charged for admissions through Samarth E-Gov portal. Therefore, except the approved admission fee, no other fee will be levied by the College/university for admission.**
19. Colleges can generate student ID Cards at the SAMARTH platform following procedures after the admission process is closed.
20. Under no circumstances, for any reason whatsoever, will the colleges give admission to any students who have not applied through Assam State Higher Education Admission Portal (<https://assamadmission.samarth.ac.in/>)
